1674E Public question time (20 minutes)

The Chair and Treasurer of Brinsworth Community Trust were in attendance.

The Chair explained that she had come along to the meeting to ask Councillors to consider what their priorities are in 2019 for The Centre to ensure that the Trust are working towards the same goal as the Parish Council. Councillors discussed the request and the trustees were informed that as part of the lease agreement a document would be drawn up by our solicitor to explain exactly what the Parish Council's expectations are for The Centre.

The Chair of the Trustees also asked if she would be ok to attend future meetings and share information with Councillors on progress and successes. The Councillors welcomed this. The Clerk will provide the Chair with future dates.

Cllr Gregory is still getting questions from a resident regarding dropped kerbs between the shops and The Three Magpies. Councillors suggested that Cllr Gregory pass the issue on to the Ward Councillors to address.

Cllr Gregory has also been approached by a local shop owner regarding the behaviour of youths around his shop throughout the day and evening. He also has an issue with rats in his workshop due to the flat next door fly tipping. The Clerk agreed to contact Brinsworth Academy and the local PCSO about the youths and suggested that the owner be advised to contact Environmental Health regarding the rats issue.

1675E Apologies
