1809E Apologies

Apologies were received from Cllr Mrs J Tompkins and Cllr J Williams and the reasons given were approved.

1806E - The Clerk updated Councillors on the Christmas decorations. Everyone agreed that The Centre looked really festive and that the lights in the village looked good too. Some Councillors felt that the Council needs to decorate more of the village and not just Brinsworth Lane. The Clerk explained that they would need to get permission from the land owners to do this and that the Christmas decorations budget would need to be significantly increased. The Clerk gave examples of the budget other Parish Councils had built in for lights in comparison to the £5,000 that Brinsworth had earmarked.

The Clerk updated Councillors on the 2 Christmas competitions and prizes that had been donated.
