## 949P Public Question Time (20 minutes)

There were no members of the public in attendance.

## 950P Apologies

Apologies have been received from Cllrs Gelder, Gregory and Jones and the reasons given were accepted.

## 952P Approval of the minutes of the meeting held on:-

## 953P To receive information on ongoing issues and decide further action where necessary

945P - The Clerk confirmed that she had written to Mr Archer regarding his sign and read out her letter. Once she has received a response this will be put on an appropriate agenda item to discuss.

937P - The Clerk had circulated the play inspection schedule to Councillors so that they can consider what work to prioritise on the play equipment. The Clerk said that she would provide a written report to help with this. Councillors thanked the Clerk for circulating the inspection sheets as they were informative. It was agreed that these should be circulated to the Premises Committee going forward.

938P - The Clerk reported that a number of complaints, including a FOI, had been received regarding the cost of the signs and what a waste of money they are. The Clerk has passed these residents on to Ward Councillors to discuss the complaint as it is their project. The sign on Brinsworth Playing Fields has also been vandalised and torn out of the ground. Ward Councillors and the contractor have been notified of this. The Clerk suggested the sign may be better sited in view of the CCTV camera.

948P - The Clerk confirmed that the dog bin posts had been ordered and were due to be delivered the following week. The Attendants will then work on repairing the broken bins.

## 954P Update on Bookings

The update on bookings had been circulated to Councillors prior to the meeting.

The Clerk suggested the Pavilion and bowling green could be advertised on social media and in the Advertiser and would put something together.

After the meeting Cllr Hollis shared with the rest of the Councillors details for the Jubilee trail that she had received from Cllr Jones.

Ward Councillors are working with Brinsworth Academy and Castings Innovations to create a Jubilee trail around the village. Residents will be able to use an App which is being designed by an Academy student to find plaques situated around the village. The plaques are being provided by Castings Innovations and will need attaching to various objects for residents to find, these will be predominantly on Council land.

Permission to place them on Council property was being requested but had not been received as an agenda item to discuss. The Councillors all felt this was an excellent idea and agreed with the Clerk that the request should be agreed in principle and ratified at a later meeting.

Cllr Hollis agreed to share the information with the Clerk so she could summarise it and send it to all Councillors for information.
